




Middle School (Grades 6-8) and High School (Grades 9-12)

- Whether students are in-person or at-home learning, they will have access to similar instruction and have the ability to interact with their peers.
- Equivalent to in-person learners in the following ways:
 - Access to each course through Google Classroom
 - Schedule aligned with normal school day (see below)
 - Live instruction with Biblical Worldview Integration
 - Real time assessments
 - Opportunity for small group work facilitated through online resources
 - Equivalent tuition
 - Parkway Report Card
 - Parkway Transcript
 - Parkway Diploma
- Daily class schedule with the following:
 - Set times for live instruction via Google Meet
 - Live instruction
 - At-home virtual students are required to be present for live instruction
 - Recorded on request or when students are absent
 - On demand recordings available based on the above
- Biblical Worldview Integration
 - Students will join LIVE classroom instruction following the block schedule below:



- Chapel once a week during Flex time
 - Either M/Tu/W depending on grade level
 - Pre-recorded chapels sent out to students
 - Possible live components through video conferencing
- Assessments
 - Students will log in to Google Meet and complete the assessment at the same time as in-person learners
 - Teacher will share the assessment with the at-home virtual learner at the beginning of the class/prior to the start of the assessment
- Students should be prepared to join via Google Meet at any time during the scheduled period
 - At-home virtual students will join Google Meet at the start of each class period to receive initial instruction
 - Possible that students could be asked to join the class a second time during the class block if a second time of instruction takes place and/or if there is a time of Q&A
 - Staff will notify student of a time to return, if known in advance of the student signing off
 - Staff will send a message to alert students to join video conferencing again, if needed
 - At-home learner may be expected to stay on the video conference call throughout the class block based on teacher discretion
- When requested or a student is absent only the instructional portion of the class time will be recorded to facilitate posting and ensure that on demand recordings remain as concise as possible
 - Small group and one-on-one work time will not be recorded, but may still be facilitated through Google Meet
 - Assessment time will not be recorded, but may still be facilitated through Google Meet
 - Q&A or lesson clarification may be recorded and posted at the instructor's discretion
- Elective Classes
 - Participation will be required and for a grade
 - Expectations for at-home learners may be different than in-person learning expectations, due to resources that may or may not be available at home
 - When feasible and appropriate there may be opportunities for LIVE lessons, otherwise on demand videos and/or assignments will be posted in Google Classroom

Virtual Learning Coordinator

- MS/HS Virtual Learning Coordinator who will facilitate the following:
 - Communication with families
 - Grade monitoring
 - Academic support
 - Social-emotional and mental health support

FAQs

- What if my in-person student has to stay home from school for a day or for a period of time? (due to having symptoms, or any other reason)
 - They will be able to log into the Google Classroom and participate from home. They can view live videos along with their class, or watch them later on demand, if absent from class.

- Will things continue to change and update?
 - Absolutely. As this is new to all of us, we will be sending out parent surveys periodically and making adjustments as needed.
- What will happen if Michigan returns to phase 1-3 and school is closed for in-person instruction?
 - All students would seamlessly transition to the At-Home Virtual Learning Plan.
